The Illinois Public Act 102-1088 requires all local units of government that levy a tax, except municipalities and counties, to convene a Decennial Committee on Local Government Efficiency to study local efficiencies and report

recommendations regarding efficiencies and increased accountability. The Decennial Committee must meet 3 times within 18 months, and must submit a summary report to the County Board.

At its initial meeting on June 27, the committee agreed that the focus of the study will be Intergovernmental Partnerships.

Objectives:

- Document all active intergovernmental agreements.
- Identify agreements requiring updates/revision.
- Establish timeline for implementation of recommended revisions.
